- Requires     Does not require 2. Exclusive buyer broker agreements
- Requires     Does not require 3. Pre-approval for a mortgage loan / proof of funds\*

\*Although Broker may not require such information, a seller of real estate may require this information prior to showing the property and/or as part of any purchase offer.
